I/We undertake to restart commercial production/activity within a period of three months from the date of receipt of financial assistance and should remain working continuously for a period of three years from the date of receipt of financial assistance,

I/We further agree that no change of location , name, activity, constitution of the unit and address of the applicant or any substantial contraction or disposal of fixed capital investment will be made within the period of three years without the prior approval of the sanctioning authority,

I/We further agree to furnish to the disbursing agency annual statement of accounts & balance sheets, valid license from local body, electricity bills and our performance particulars in the prescribed proforma every year till the stipulated period of three years before the 31st December of the ensuing year, as a proof of our functioning,

I/We also undertake to refund to Government any sum received as investment support with interest as might be prescribed by the Government or in the absence of any such fixation with interest at 14%, if;

i) My/our unit failed to restart commercial production within three months from the date of receipt of financial assistance, or

ii) My/our unit goes out of production within three years from the date of receipt of financial assistance

iii) I/We violate any of the terms and conditions stipulated for the purpose of the scheme, or

iv) The disbursing agency intimates me/us in writing that the assistance has been obtained by me/us by misrepresentation or/by furnishing of false information as to an essential fact in my/our application for assistance and supporting documents submitted by me/us.
