### ORDER

As per the Government Order read as 1<sup>st</sup> paper above Shri.Sajith Kumar. K, Assistant Director in the Department of Industries & Commerce was suspended from service on public interest, consequent to a Criminal Case No.326/2014 (under section 376 (C)(b) of Indian Penal Code) was registered against him by the Circle Inspector of Police Ernakulam Central and the case charge sheeted before the Hon'ble Judicial First Class Magistrate II Court, Ernakulam on 20.07.2014.

Now the Hon'ble Court of Additional District and Sections Judge, Ernakulam in its judgement read as 2<sup>nd</sup> paper above, has acquitted Sri.Sajith Kumar.K from all the charges levelled against him and declared that the accused is not found guilty of the offence punishable under section 376 (C)(b) of Indian Penal Code and he is acquitted under section 235(1) of Criminal Procedure Code.

Consequent on this, Sri.Sajith Kumar.K as per his representation read as 3<sup>rd</sup> paper above has requested to reinstate him into service in the light of the above judgment. The Director of Industries and Commerce in his letter read as 4<sup>th</sup> paper above has recommended the request and requested the Government to grant him posting as Assistant Director, District Industries Centre, Kasaragod by transferring the present incumbent Shri.Anoop.S to District Industries Centre, Ernakulam.

Government have examined the matter in detail and are pleased to reinstate Shri.Sajith Kumar.K. Assistant Director into service as the Hon'ble Court




charges levelled against him. On reinstatement, Sri.Sajithkumar.K is posted as Assistant Director in the District Industries Centre, Kasargod vice Shri.Anoop.S, Assistant Director transferred. On transfer Sri.Anoop.S Assistant Director is posted as such in the District Industries Centre, Ernakulam in the existing vacancy.


